

#### **Market Share - ON MARKET Traded Value and Trends**






#### **OFF-MARKET Value**

**Dark** represents the execution of orders that were not displayed prior to execution.


**Lit** represents the execution of orders that were displayed prior to execution.


**Dark Block** means any **Dark**, **Off-Market** trade that makes use of the block special size threshold or portfolio special threshold.

All of the above are included in the off-market reported value. TradeMatch is the ASX central limit orderbook. The TradeMatch totals include trades matched during the opening and closing auctions. Centre Point is the ASX anonymous mid-point matching service.
